



Parent Plus Title IV Authorization Form

Southeast Community College, in compliance with federal regulations, must obtain written authorization from parents of undergraduate students to apply Title IV funds (Parent Plus Loan) for payment of charges other than institutional charges (tuition, fees, room and board) on a student's account and to use these funds in payment of prior aid year non-institutional charges.* Permission is also required to allow excess of federal funds to transfer to a future term to pay for future charges within the same financial aid award year (Fall, Spring and Summer terms).
